

# Compliance with EU Taxonomy regulation EU2021/2139 Appendix C

Troldekt products are Cradle to Cradle certified<sup>®</sup> at Gold level (ver. 3.1, certificate 6125). The requirements in Cradle to Cradle at Gold level are levelled with or more stringent than the requirements in the EU Taxonomy regulations.

We hereby confirm that all Troldekt wood wool products meet the DNSH (Do No Specific Harm) criteria for Objective 5 "Pollution prevention and control" in the EU Taxonomy Regulation (EU) 2021/2139.

More specifically, the products comply with point a) to f) in Appendix C of abovementioned as they do not contain any of the substances regulated by the following:


- a) Substances listed in Annexes I or II to Regulation (EU) 2019/1021
- b) Mercury and mercury compounds as defined in Article 2 of Regulation (EU) 2017/852
- c) Substances listed in Annexes I or II to Regulation (EC) No 1005/2009
- d) Substances listed in Annex II to Directive 2011/65/EU, except where there is full compliance with Article 4(1) of that Directive
- e) Substances listed in Annex XVII to Regulation (EC) 1907/2006, except where there is full compliance with the conditions specified in that Annex
- f) Substances in a concentration above 0,1% weight by weight (w/w) and meeting the criteria laid down in Article 57 of Regulation (EC) No 1907/2006 and that were identified in accordance with Article 59(1) of that Regulation for a period of at least eighteen months, except if it is assessed and documented by the operators that no other suitable alternative substances or technologies are available on the market, and that they are used under controlled conditions

Substances in a concentration above 0,1 % weight by weight (w/w), that meet the criteria of Regulation (EC) No 1272/2008 for one of the hazard classes or hazard categories mentioned in Article 57 of Regulation (EC) No 1907/2006, except if it is assessed and documented by the operators that no other suitable alternative substances or technologies are available on the market, and that they are used under controlled conditions

In addition, Troldekt has performed testing in accordance with EN 16516:2017 +A1:2020 and ISO 16000-3:2022 to verify that the products comply with:

Formaldehyde concentration less than 0,06 mg/m<sup>3</sup> upon testing in accordance with the conditions specified in Annex XVII to Regulation (EC) No 1907/

Carcinogenic compounds concentration less than 0,001 mg/m<sup>3</sup> upon testing in accordance with CEN/EN 16516:2017 or ISO 16000-3:2011:2021 or other equivalent standardised test conditions and determination methods
